**Effective August 28, 2026.** These terms govern the Kennedy Roofing text messaging program. By opting in, you agree to them.

---

#### 01 **The program**

Kennedy Roofing & Construction (213 S Sunnyslane Rd, Moore, OK 73160; Oklahoma License #80000269) operates a text messaging program that sends customers and prospective customers information about their roofing project. Messages may include:

- Inspection and appointment confirmations and reminders
- Crew arrival windows, material delivery notices, and weather delays
- Job status and completion updates
- Insurance claim and document requests
- Invoice and payment reminders
- Replies to questions you text us

#### 02 **How you opt in**

You are enrolled only if you take an affirmative action to opt in ? checking the messaging consent box on our web form or on your contract, providing your mobile number and agreeing to texts in person or by phone, or texting our number first.

**Consent is not a condition of purchase.**

You do not have to agree to receive text messages to get an inspection, an estimate, or any service from Kennedy Roofing. You may decline and still work with us ? we will call or email instead.

### 03 Frequency, cost, and delivery

#### MESSAGE FREQUENCY

Varies by project stage. Approximately 2-6 messages per month, up to 10 per month during active construction.

#### COST

Message and data rates may apply. Kennedy Roofing does not charge for texts; your carrier's standard rates apply.

#### DELIVERY

Carriers are not liable for delayed or undelivered messages. Delivery is not guaranteed on every device or network.

### 04 Opting out

Text **STOP** to any message from us at any time. You will receive one confirmation message and then no further messages. You may also call our office at (405) 363-0353 or reply to any message asking to be removed.

If you opt out and later want messages again, text **START** or opt in again through any of the methods in Section 2.

### 05 Getting help

Your mobile number and messaging consent are handled under our Privacy Policy. No mobile information will be shared with third parties or affiliates for marketing or promotional purposes. Text messaging originator opt-in data and consent are never shared with any third party, affiliate, or lead generator.
